GENERAL OCCUPATION AND INDUSTRY MAPPING CLARIFICATIONS

This document is a companion document to the Idaho COVID-19 Vaccine Advisory Committee (CVAC) Vaccine Prioritization document posted on the Governor's coronavirus website¹. The following list includes occupations or industries for which clarification was requested or anticipated and did not meet criteria for bringing to the Idaho COVID-19 Vaccine Advisory Committee (CVAC) for a vote² as well as groups for which a CVAC vote did not result in a definitive prioritization —it is not intended to include all occupations or industries in Idaho. Mapping to an Idaho COVID-19 vaccination group is based on previous CVAC recommendations, Cybersecurity & Infrastructure Security Agency (CISA) guidance³, Advisory Committee on Immunization Practices (ACIP) and Centers for Disease Control and Prevention (CDC) recommendations⁴, CDC's interim list of categories of essential workers mapped to standardized industry codes and titles⁵, the 2017 North American Industry Classification System (NAICS) Manual⁶, the Standard Occupational Classification (SOC) System⁷, and subject matter expertise.
