The consensus of the Council was there has been no advantage of being a member of NALBOH throughout the years, and most districts are not current members. At the IADBH business meeting on June 9, Elt Hasbrouck, Council Chair, will recommend that Idaho not have a representative on the NALBOH State Leadership committee.

Motion: Vaughn Rasmussen (D6) made a motion not to have a SALBOH representative on the NALBOH State Leadership committee. Georgia Hanigan (D3) seconded. Motion carried.

- 3. Discuss and determine a recommendation for the Idaho Association of District Boards of Health on pursuing legislation during the 2023 session to remove the food establishment license fees from Idaho Code*Elt Hasbrouck*

Since the public health districts are now under the counties, the Executive Council has agreed that the food establishment license fees should be removed from Idaho Code and will make the recommendation at IADBH. The Council stated they would be looking to the District Directors for direction and support.
